targeted at-risk young teenage boys who may come from broken homes or other at-risk
situations and provide a place for them to belong and be mentored by an adult male,
as if the boy had a big brother or father image to help encourage him to accomplish
more in his life and raise his self-esteem. This ultimately provides a sense of
belonging and self-worth.
